Calvary St Augustine Episcopal Church does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user acknowledge, accept and agree that Calvary St Augustine Episcopal Church shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products.
